LinMotion attaches great importance to the careful handling of personal data. We therefore process and protect personal data with the utmost care. Use of personal data

1) Registration

We will not pass on the linked data to third parties unless this is necessary for the performance of the agreement you enter into with us, or if this is required by law. In the event of a suspicion of fraud or misuse of our website, we may pass on personal data to the competent authorities.

We do not publish your data.

Disclosure to third parties

Your personal data is only shared with parties that have a legitimate interest in viewing it, have a legal obligation to view it, or which are important to the performance of the agreement. Even then, data is only shared if strictly necessary. Your data is not shared with parties outside the European Union.

Use of cookies

LinMotion only places cookies that are necessary for the website to function correctly. Use is also made of cookies whose effect is less directly apparent, such as Google Analytics cookies. We use anonymized data to improve your website experience. Without this information we cannot improve our website.

Cookies that are placed for analytical purposes or for advertisements are also referred to as 'third party cookies'. They are not placed by us, but by the partners we work with. For this reason, we cannot take responsibility for them. If you do not want to use cookies, you can disable them via your own browser.

To measure the business use of our website, we use the Leadinfo service from Capelle aan den IJssel. This service shows us company names and addresses based on IP addresses of our visitors. The IP address is not shown.

A brief overview of the cookies we place.

Analytical cookies

We use Google Analytics to analyze how many visitors our website has and which pages they view. Google Analytics places cookies for this purpose. We use this anonymized information to improve our service.

Functional cookies

We use these cookies to recognize your computer (or smartphone, tablet etc.). Without these cookies, certain parts of the website cannot be used properly. We use the cookies to recognize certain preferences or settings that provide you with the right experience.

Session Cookies

A session cookie enables us to see which parts of the website you have viewed during your visit. That makes it possible for us to adapt our service to your browsing behaviour. Session cookies are automatically deleted as soon as you close your web browser.
